

Information Notice
Pursuant to Art. 13 of the Regulation (EU) no. 2016/679

Dear Sir/Madam,

Please be informed that Regulation (EU) No 2016/679 "General Data Protection Regulation" provides for the protection of natural persons with regard to the processing of personal data. According to such regulation, this processing will be based on the principles of lawfulness, fairness and transparency, adequacy, relevance, purpose and storage limitation, accuracy and updating, data minimization and accountability, pursuant to Art. 6, par. 1 lett. a) of the GDPR, with your prior consent.

We, therefore, provide you with the following information:

1. The data you provide for the event DISCOVERY SCIENCE_10-14 October 2024

a) name, surname, email address, reference structure, University ID number;

b) possible image, recorded voice;

will be processed solely for dissemination and promotional purposes for the following purposes:
data referred to in point a):

- I. to enable registration for the event DISCOVERY SCIENCE, and all the organizational activities following from the registration for the event;

data referred possible in point b):

- II. for the possible event recording;
- III. for possible publication and/or streaming of the event on a public web portal of the conference);
- IV. for possible the provision of audio, video and/or photo material for promotional purposes.

2. The data will be retained for as long as necessary for the purposes they were collected for and deleted after 12 months from the scheduled conclusion of the event.

3. Participation in the event is on a free and voluntary basis and the provision of data is mandatory for that purpose. Any refusal to provide such data results in:

- regarding the purposes referred to in point I) the impossibility of registering for the event;
- regarding the purposes referred to in points II) and III) your image redaction and no recording of your voice;
- regarding the purposes referred to in points IV) the impossibility of being included in the audio, video and/or photo material.

You may revoke your consent at any time without affecting the lawfulness of the processing based on the consent given before the revocation.

4. The data referred to in point a) will not be disclosed to other parties and/or will / will not be subject to dissemination (*undefined third parties*). The data referred to in possible point b) will not be disclosed to other parties and/or will not be subject to dissemination (*undefined third parties*).

Please note that, once made public, audio, video and/or photo material may be taken by third parties, thus getting out of the University's control, and that the University of Pisa shall be exempt and held harmless from any liability arising from misappropriation and/or misuse of the aforesaid material.

5. The Data Controller is the University of Pisa, with registered office in Lungarno Pacinotti 43, Pisa, represented by the pro tempore Rector.
6. The Designated Representative of the Data Controller is Prof. Vincenzo Ambriola *Director of Department Computer Science* at the University of Pisa.
7. The persons authorized to data processing are the members of the conference organizing committee.
